

Hey Bambini – Australia Subscriber Competition

Terms and Conditions

1. Information on how to enter and prizes form part of these conditions of entry. Entry into the competition is deemed acceptance of these conditions of entry. Entry is via email.
2. Entry is open to all Victorian residents. Employees and their immediate families of HEY BAMBINI AUSTRALIA, suppliers, providers and associated with this promotion are ineligible.
3. The monthly Subscriber competition for HEY BAMBINI commences on the 1st of every calendar month 9.00 am (AEST) and concludes on the 31st of every calendar at 11.59pm (AEST)
4. To enter the promotion, participants must:
 - (a.) subscribe to the HEY BAMBINI monthly newsletter. A valid email address must be provided and upon entry applications will receive a confirmation email informing them of their entry and subscription.
 - (b.) Upon submitting their details, participants may also 'refer a friend' by entering additional emails. If referred friend enters the competition the referee is eligible for an additional entry towards prize.
 - (c.) Existing subscribers to the HEY BAMBINI may also enter but only if they 'refer a friend'. If friend enters competition and subscribes to the monthly newsletter existing subscribers gain an entry.
5. Entrants can only enter their own name and use their own email address. The Promoter reserves the rights to request winners to provide proof of age, identity, proof of residency at the nominated prize delivery address, and/or proof of entry validity. Proof of identification, residency and entry considered suitable for verification is at the discretion of the Promoter. The Promoter reserves the right to validate and check the authenticity of any prize claim or entry before awarding a prize.
6. Entries will be deemed to be accepted at the time of receipt and not at the time of transmission. Incomplete or incomprehensible entries will be deemed invalid. No responsibility will be taken for lost or misdirected entries.
7. The computerized random draw will take place at 1.00pm at that the Promoters registered address on the 2nd of the following month. The winner will be notified by email within 2 working days of the draw date.
8. Prizes: The first eligible entry drawn from all entries which subscribed to the monthly newsletter received the nominated prize of the month valued under \$100.

9. The prize must be taken as offered and cannot be varied. Prize value is GST inclusive and in Australian dollars and is the recommend retail value as provided by the supplier and is correct at time of printing. The Promoter accepts no responsibility for any variation in prize value.
10. The Promoter's decision in relation to any aspects of the competition is final and binding on every person who enters and no correspondence will be entered into.
11. The Promoter and their associated agencies, and companies associated with this promotion will take no responsibility for prizes damaged or lost in transit. Once prizes have left promoter premises, the promoter will not be responsible for any delay in delivery, or failure of safe delivery prizes.
12. The Promoter shall not be liable for any loss or damage whatsoever which is suffered (including but not limited to indirect or consequential loss) or for any personal injury suffered or sustained in connection with any prize/s except for a liability which cannot be excluded by law.

The Promoter is not responsible for any incorrect or inaccurate information or for any of the equipment or programming associated with or utilised in this competition, or for any technical error, or any combination therefore that may occur in the course of the administration of this competition including any omissions, interruption, deletion, defect, delay in operation or transmission, communications line or telephone, mobile or satellite network failure, theft or destruction or unauthorised access to or alteration of entries.

The Promoter reserves the rights in its sole discretion to disqualify any individual who the Promoter has reason to believe has breached any of these conditions, or engaged in any unlawful or other improper misconduct calculated to jeopardise the fair and proper conduct of the promotion. The Promoter's legal rights to recover damages or other compensation from such an offender are reserved.
15. All entries become the property of the Promoter. All entries will be entered into a database and The Promoter may use the entrant's names, addresses and telephone numbers for future promotional, marketing and publicity purposes that strictly relate to the HEY BAMBINI site. No names or address will be passed or sold on to other companies or businesses.
16. If for any reason the competition is not capable of running as planned, including due to infection by computer virus, bugs, tampering, unauthorised intervention, fraud, technical failures or any other causes beyond the control of the Promoter, which corrupt or affect the administration security, fairness or integrity or proper conduct of this promotion, the Promoter reserves the right in its sole discretion to disqualify any individual who tampers with the entry process, and can cancel, terminate, modify or suspend the promotion.
17. In the case of intervention of any outside agent or event which naturally changes the result or prevents or hinders its determination, including but not limited to vandalism, powers failures, tempests, natural disasters, acts

of God, civil unrest, strikes; the Promoter may in its absolute discretion cancel the event and recommence it from the start on the same conditions subject to State Regulation.
